## Who's Eligible

Persons who are expected to be out of work for at least one year as a result of a physical or mental impairment. If you have been out of work for a year or more already, you should immediately contact our office to begin your claim process.

## Social Security Disability Pays:

- Monthly cash payments to you and eligible members of your family.
- Retroactive disability payments.

## The Process

- 1.** File an application with the Social Security Administration. SFSM handles this on your behalf.
- 2.** If your claim is approved, you will begin to receive benefits. However, since most claims are denied, you must appeal the decision. SFSM handles this on your behalf.
- 3.** Your appeal will be heard by an Administrative Law Judge; however, it may take up to six months or a year before there is a hearing.
- 4.** If the decision made by the judge is favorable, you will begin receiving benefits a short period thereafter. If your appeal is denied, it can be appealed to the Appeals Council.
