- You are arrested for no reason during a routine stop
- You are arrested as a result of racial or minority group profiling
- There is negligence in jail or prison
- Law enforcement uses excessive force

Civil rights violations can also occur when you are discriminated against based on:

- Age ■ Disability ■ Race
- Nationality ■ Gender ■ Religion

BANKRUPTCY & FORECLOSURE

WHAT TO DO IF YOU ARE IN AN ACCIDENT

If you have been in an accident, be sure to:

- Call 911 to contact the police and an ambulance, if one is needed.
- Exchange insurance, registration and driver's license information.
- Do not claim responsibility.
- If there are witnesses, get their names, addresses and phone numbers.
- If you are injured, seek medical care at a hospital or your physician's office.
- If you are in an accident involving injury or property damage, contact your insurance company. If you fail to do so, your claim may be refused.
